RESERVATION + PAYMENT

- A signed agreement and 50% nonrefundable reservation retainer are required to secure the date.
- Dates are not held by inquiry, verbal discussion or an unsigned proposal.
- The final balance, guest count, hat sizes, colors and menu selections are due 10 calendar days before the event.
- Bookings made within 10 days of the event require full payment when accepted.
- Charges are based on the guaranteed guest count even if fewer guests attend. Applicable taxes and approved outside-vendor charges are additional.

HATS + CUSTOMIZATION

- Each paid package includes one base hat from the selected collection at its listed starting value.
- Hat sizes, preferred colors and design direction must be finalized 10 calendar days before the event.
- Natural felt and handmade finishes may show slight variations in color, texture and shape.
- Material changes, premium accessories, extensive burning and work beyond the package allowance are charged separately.
- Customized hats and completed accessories are final sale. Upgrades must be paid before finishing begins.

CANCELLATION + RESCHEDULING

- The reservation retainer is nonrefundable because the date, staffing and inventory are committed to the event.
- One reschedule may be requested with at least 21 calendar days' notice, subject to availability and a \$150 rescheduling fee.
- A transferred event must occur within 90 days of the original date. New pricing may apply if the package scope changes.
- Cancellations or date changes requested fewer than 21 days before the event are not eligible for a credit unless LE'BRIM agrees otherwise in writing.

FOOD + WINE SERVICE

AGREEMENT TERMS

These terms protect the date, inventory, staff and guest experience reserved for the client.

1. RESERVATION AND PAYMENT

The date is secured only after this agreement is signed by both parties and LE'BRIM receives the 50% nonrefundable reservation retainer. An inquiry, proposal, verbal discussion or unsigned agreement does not hold a date. The final balance is due 10 calendar days before the event. Bookings accepted within 10 days of the event require full payment. LE'BRIM may cancel an unpaid reservation after written notice of a missed payment deadline.

2. GUARANTEED GUEST COUNT

Private packages require at least 5 paid guests and may accommodate no more than 20 guests unless LE'BRIM approves otherwise in writing. The guaranteed guest count, hat sizes, preferred colors and menu selections are due 10 calendar days before the event. Charges are based on the guaranteed count even if fewer guests attend. Additional guests require advance approval and payment and remain subject to inventory, staffing and lawful occupancy.

3. PACKAGE PRICING AND ADDITIONS

MODE is \$195 per guest, SAUVAGE is \$295 per guest and RÈGALÍA is \$395 per guest. Package pricing includes one base hat from the selected collection for each paid guest. Starting hat values are MODE \$175, SAUVAGE \$250 and RÈGALÍA \$350. Material changes, premium accessories, detailed burning, specialty shaping and work beyond the package allowance are additional. Applicable taxes and approved vendor charges are added to the invoice.

4. EVENT TIME AND OVERTIME

Reserved time includes guest arrival, Hat Bar activities, photographs and departure. Late arrival does not extend the scheduled end time. Any extension must be approved by LE'BRIM and is charged at \$75 per hour. The client is responsible for communicating the arrival time and schedule to all guests and vendors.

5. HATS, CUSTOMIZATION AND FINAL SALE

Natural felt and handmade finishes may show slight variations in color, texture and shape. The client must review and approve final group selections by the stated deadline. Customized hats and completed accessories are final sale. All upgrades must be paid before finishing begins. LE'BRIM may substitute a reasonably comparable item when an approved material becomes unavailable, but will discuss material changes with the client whenever practical.

6. CANCELLATION AND RESCHEDULING

The reservation retainer is nonrefundable because LE'BRIM commits the date, staffing and inventory to the event. The client may request one reschedule with at least 21 calendar days' notice, subject to availability and a \$150 rescheduling fee. The transferred event must occur within 90 days of the original date. Cancellations or date changes requested fewer than 21 days before the event are not eligible for a credit unless LE'BRIM agrees otherwise in writing. New pricing applies if the package, guest count or event scope changes.

7. FOOD, ALLERGIES AND CATERING

Food selections depend on dietary information and caterer availability. The client must disclose known allergies and dietary needs by the final-selection deadline and is responsible for obtaining accurate information from guests. LE'BRIM and its vendors cannot guarantee an allergen-free environment. Outside food or caterers require advance written approval and must follow venue access, sanitation and cleanup requirements.

8. WINE AND ALCOHOL SERVICE

MODE does not include wine. SAUVAGE and RÉGALÍA include only the wine service stated in the selected package. Alcohol service is limited to guests age 21 or older with acceptable identification and is subject to all required licenses, permits and trained service. No outside alcohol or BYOB is permitted without advance written approval. LE'BRIM may refuse service or modify alcohol service when required by law, permit conditions or guest safety.

9. STUDIO CONDUCT, DAMAGE AND PERSONAL PROPERTY

The client is responsible for the conduct of guests and approved vendors. Smoking, vaping, illegal substances, glitter, loose confetti and open flames are prohibited. The client is responsible for direct damage, missing LE'BRIM property or excessive cleaning caused by the client's group or vendors. LE'BRIM is not responsible for unattended personal items. Unsafe, unlawful or disruptive conduct may end the event without refund.

10. OUTSIDE VENDORS, DECOR AND ACCESS

All outside vendors, décor, deliveries and installations require advance written approval. Vendors must follow the assigned access window, protect the premises and remove their property by the scheduled departure time. The client remains responsible for vendor conduct and charges. Nothing may be attached, altered or installed in a manner that damages the venue or interferes with required exits, safety equipment or lawful occupancy.

11. CIRCUMSTANCES BEYOND REASONABLE CONTROL

If an event cannot proceed because of severe weather, government action, utility failure, emergency conditions or another circumstance beyond a party's reasonable control, the parties will first attempt to reschedule. Any refund or credit for undelivered services will be determined after deducting nonrecoverable third-party costs already approved for the event. This section does not excuse amounts already due for services or customized products already completed.

12. ENTIRE AGREEMENT AND GOVERNING LAW

This agreement, the accepted proposal or invoice, and any written attachment identified by both parties contain the agreement for the event. A change is effective only when confirmed in writing by both parties. If a provision is unenforceable, the remaining provisions continue in effect. Georgia law governs this agreement. Electronic signatures and counterparts may be used to execute it.
